NOTICE OF HEARING

By the authority of the General Statutes of Connecticut, §4-177, you are hereby notified to appear before a duly authorized panel of the Connecticut Medical Examining Board, to include **John Russell, MD** and **Grant H. Miller, Jr., Esq.**, for a formal hearing on your request for reinstatement of your physician/surgeon license.

The hearing will be held on **Monday, July 16, 2001, from 1:00 p.m. to 4:00 p.m.**, at the Department of Public Health, 410 Capitol Avenue, Hartford, Connecticut, in Conference Room I on the second floor.. The scheduling of your case is subject to change. You are urged to call (860) 509-7648 the day before the hearing to verify this schedule.

At the aforementioned hearing, you may be represented by an attorney and present evidence on your behalf. Although you may represent yourself (pro se), you are urged to obtain the services of an attorney. The hearing will be conducted in accordance with Chapter 54 of the General Statutes and § 19a-9-1, et seq., of the Regulations of Connecticut State Agencies (Public Health Code). Any documentation offered into evidence must be accompanied by five (5) photocopies.

If you fail to appear at the hearing, upon proof that due notice was served upon you to appear, the Board may proceed in the same manner as though you were present in person.


ORDER Re: Filings
